

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.virtualskyaviation.com and Virtual Sky Aviation (VSA) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to VSA include www.virtualskyaviation.com and VSA. The VSA website is a flight simulation site. By using the VSA website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, VSA may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through VSA public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Tracking User Behavior
